The OML Board believes that OML is trading at a discount to its intrinsic value and is of the view that a Repurchase Programme will deliver longer term incremental value to shareholders. The purpose of the Repurchase Programme is to reduce the share capital of the Company.

The repurchased shares shall be cancelled as issued shares and will revert to authorised but unissued share capital status.
